### **Minutes From Prior Meeting Approval**

• Motion made to approve minutes from October 9th, 2017; seconded; approved 4-0, 1 abstention.

#### **Financial Status**

- Discussion on why low event income (no 4th of July BBQ nor carnival; also we put Swim Team events in Swim Team as opposed to "Events").
- On CDs talked to Morgan Stanley reviewed CDs and made determination to make adjustments.
- Electrician had to redo rewiring.

- With new solar panels, roughly 10 to 20% of power is coming from panels. In progress on understanding the data more completely.
- Swim lessons more kids teaching and using MindBody which is much more efficient. Income up.
- Renegotiated MindBody arrangement.

## **Managers Report**

- 2018 budget to be presented...reviewing over next few weeks and will discuss next month.
- No correspondence on accident from late summer.
- Skateboard ramp land prepped and ready.
- Pumpkin carving; 25 to 30 attendees, a great event!
- Caroling December details in progress
- Website compliance updates complete
- Swimming pool leaks in progress on fix
- Tennis courts light outage; 5 out of 16...one night working, the next not.
  - Hopefully set in next couple weeks
- 3 complaints about tennis courts being occupied by lessons on Sunday mornings
  - Historically we have been holding lessons all day on Sunday
  - Plan to continue with our current situation steady state as overall feedback on updated program has been very positive
  - Will update signage on tennis message board as necessary
- Tennis light proposal (more lights) research in progress

- Land prepped and ready to go
- To communicate with skateboard committee approval to go forward with purchase of ramp

### **Pool Committee Update**

- General
  - Meetings held with Adams Pools and ArchPak
  - Update on fundraising research
- Details
  - Adams Pools proposal received over the weekend start to finish POC
  - ArchPak
    - They get us through design, steps back during construction and then comes back and checks in to make sure everything to spec
  - Pool committee to reconcile / work towards "apples to apples" comparison of different bids
- Fundraising discussion
  - Assuming a 12 month process for pool; e.g.:
    - 2 months fine tune drawings
    - 2 months permitting
    - 1 month for bidding
    - 6 months for construction
    - So...by April 2018 likely need to have funding to to be confirmed to open in April 2019
    - We have flexibility in timing

- General discussion
  - Can we take a loan out and what does that look like we will check in with bank
  - Bond not much interest in exploring this financing path
  - Need a firm number what the LRD can contribute
    - To confirm number from capital reserve study
  - Will need a lot of help on fundraising a big effort
  - Nov / Dec pretty tapped out for financing work; likely best to start fresh in Jan
